Each party agrees to indemnify and hold harmless the other party from and against any and all claims, damages, liabilities, and expenses arising from the breach of this Contract or any illegal activities related to the provision of  
.prostitution services

## **Governing Law .7**

This Contract shall be governed by and construed in accordance with the laws of

Any disputes arising out of or in connection with this Contract shall be resolved through arbitration in accordance with the rules of the [Arbitration Association],
